



REGULAR FEES BELIZE INTERNATIONAL BUSINESS COMPANY (IBC)

\$ 1350 – PREMIUM INCORPORATION PACKAGE

This package is designed for clients located and doing business in highly regulated, high-tax countries. This package deals with the “place of mind and management” test for offshore companies ! Designed to withstand foreign tax scrutiny.

Includes the following:

- Belize IBC formation with all primary documents.
- The company registration fee to the Belize government (\$100).
- A set of copies of the primary documents certified by Notary and *Apostille* for international use.
- Registered agent service for one year.
- Directorship service for one year.
- Shareholder service for one year.
- Business address, fax, mail and document management service for one year.
- Basic consultation and advice for one year.
- Delivery of the original corporate documents by courier.

Local bank account introduction in Belize: **\$ 250** (plus disbursements)
Foreign bank account introduction: **\$ 500** (plus disbursements)
Annual fees from 2nd year: **\$ 1000** (includes the \$100 annual Government fee).

\$ 790 – BASIC INCORPORATION PACKAGE

The simple, “no-frills” package.

*This package is designed for those clients, who can afford to be seen as directly managing their offshore IBC. Only suitable for those individuals, who live and do business in a location, where they are **not** subject to a highly intrusive tax authority.*

Includes the following:

- Belize IBC formation and all primary documents.
- The company registration fee to the Belize government (\$100).
- A set of copies of the primary documents certified by Notary and *Apostille* for international use.
- Registered agent service for one year.
- Delivery of the original corporate documents by courier.

Local bank account introduction in Belize: **\$ 250** (plus disbursements)
Foreign bank account introduction: **\$ 500** (plus disbursements)
Annual fees from 2nd year: **\$ 350** (includes the \$100 annual Government fee).

A COMPLETE LIST OF REGULAR FEES – CUSTOM ORDERS

These fees apply to all individual “custom” incorporation orders, company renewals, administration and management work. Some of these fees are mandatory, some are optional. Some of the fees are alternatives to each other. A flexible discount system applies to all company formation orders, depending on their configuration.

Official fee to the Belize Government (maximum fee) - for companies with authorized share capital exceeding \$50'000 and with all shares having a par-value.	\$ 1000

BUSINESS MANAGEMENT AND ADMINISTRATION SERVICES These services are essential to demonstrate the substance and independent “mind and management “of the IBC for foreign tax purposes.	
Provision of a business address facility in Belize, handling of faxes, business correspondence, contracts, invoices and commercial documents. (An annual undertaking fee. Actual disbursements and execution charges, if any, are additional.)	\$ 250
Call handling service. (An annual undertaking fee. Actual disbursements and time-spent are charged extra.)	\$ 400
Review and execution of commercial documents (contracts, forms, resolutions, invoices, letters, bank and brokerage instructions) – per document/transaction. (Actual disbursements, if any, are charged extra.)	\$ 50
Time-based professional fees for business management and administration work, as carried out by a senior member of staff. These fees only apply to non-standard, individual and client-specific tasks, which do not fall under other provisions of this fees schedule.	\$ 150 per hour

TERMS OF PAYMENT

The only grounds of payment is an official invoice, issued by Fidelity Overseas Ltd. Please do not remit any payment before all order/renewal details are clarified and a detailed services invoice is issued.

Unless specifically agreed otherwise, full payment is required before any services are provided.

Payment deadlines, as indicated in the invoice, must be met. Late payments for company renewal will result in additional fines by the Government and will require additional costs to reinstate the company in good standing.

Payment can be made by **bank wire transfer, by a western union cash transfer** or by a **credit card**. If You wish to pay by any alternative method, please consult with our staff on availability and conditions.

For payments by bank wire transfers – our bank account details will be provided in the invoice. All remitting bank charges and any intermediary bank charges must be borne by the sender (You). Please ensure that You tick "all charges paid by payer" when submitting payment order to Your bank. Receipt of an incomplete amount will result in no work done on the respective order until full payment.

For payments by credit card – a credit card authorization form will be provided in the invoice. This form should be completed, signed and faxed or scan-emailed back to us. We recommend using credit card only for small payments.

The standard currency for payment is US dollar. If You wish to make a payment in an alternative major currency, like EUR, it may be possible, but please request our staff to quote the rate and the precise invoice amount in the alternative currency. Payment made in an alternative currency without obtaining a prior rate quotation from us may result in incomplete payment and no services rendered until full payment is received.
